HCHC CFLFBRATES COMPLETION OF SURGERY DEPARTMENT



IN APPRECIATION



WHAT'S NFXT?

Henry County Health Center is committed to meeting the growing and changing healthcare needs of the communities we serve. After a thorough assessment of our communities current and future healthcare needs, we developed a multi-phased facilities master plan. This includes construction of a new Energy Center and Surgery Department, as well as enhancements to Outpatient and Specialty Clinic areas.

PHASE ONE: Construction of the new Energy Center was completed in summer 2012. The building provides the electrical, heating and cooling supply, allowing for future growth and sustainability.

PHASE TWO: Populating the Energy Center with equipment that provides the infrastructure to the organization is also complete.

PHASE THREE: Construction of a new Surgery
Department and expansion of Outpatient and
Specialty Clinic areas. The Surgery Department was
completed in September 2013. Remodeling has
already begun for Outpatient and Specialty Clinic
areas to expand and improve efficiencies within these
areas. When Phase Three is completed, HCHC will offer
area residents:

- Improved patient registration area
- Remodeled outpatient services area
- A new laboratory with private lab draw stations
- Room improvements for outpatient cardiopulmonary services
- A Women's Center in Radiology

- Additional Specialty Clinic exam rooms for visiting specialists
- A Health Education Center for educational classes and training
- Exterior canopy to shelter Radiology patients from adverse weather conditions

CURRENT CONSTRUCTION

Now that the Surgery Department is finished, visitors will notice that the Frontage Road has reopened, and parking spaces have been restored at the front of the health center. The construction work has moved indoors as the focus has shifted to the new Lab and the Health Education Center. Also slated for construction are the new restrooms to replace the restrooms that were located by the former Health Education Center. The Gift Shop also underwent some remodeling. In the near future, it is anticipated that work on the walkway to the MRI trailer will begin when the design is completed and approved. Work on the Specialty Clinic, central waiting area, restrooms and Women's Center will follow. The anticipated date of completion is Spring 2014.

Occupational Therapy helps local man with recovery process

After undergoing hand surgery, Mike Hampton of Mt. Pleasant looked to Henry County Health Center for his therapy needs.

The appeal of coming to Rehabilitation Services was two-fold – Hampton knew he would receive high quality, personalized care and he would receive this care conveniently in his own community.

He underwent the three hour surgery to correct an inherited condition of contracting tendons in his left hand ring finger, little finger and thumb. Hampton had lost so much strength in his hand that he was not able to hold a cup for any length of time and he could not straighten his two fingers and thumb. The purpose of surgery was to regain use of his hand and fingers.

Hampton had surgery on July 10 and was already in therapy on July 15. He reports great progress of gaining movement in all fingers with therapy. Recently he reached a great accomplishment of taking his thumb and touching the other four fingertips, a feat he had been unable to do for years due to tissue buildup in his hand.

"Val is great! She pushes me, but at the same time is understanding of my limits. By carrying on a conversation, she is able to draw me away from what is taking place. She has a great way of explaining what she is

doing and why. Val also built a hand cast for protection of the surgery site and has me do specific exercises that have been beneficial in my recovery."

Hampton found one of the benefits of rehab at HCHC is the short travel time to appointments. He also noted that Rehab Services staff has been helpful in all aspects, from scheduling appointments to therapy.

"HCHC Rehabilitation Services is a great place to go. Their service to us all is unbelievable. I have gained so much more respect for what they do for their patients now that I am the patient. Being in athletics my whole life, I have had athletes go through therapy for injuries, but this is the first time for me. The staff in Rehab are so valuable, and I strongly recommend HCHC Rehab Services. They are such a valuable asset to the community!"



HCHC's Occupational Therapist Valerie Felland, OTR/L, provides therapy for inpatients and outpatients. She treats a large percentage of patients with orthopedic conditions and custom fabricates splints for the upper extremity. She also treats hospitalized patients for neurological diagnosis or any diagnosis that causes the patient to lose function.
